Directions. From the north: Take St. Rt. 7 south to the St. Rt. 150 exit (Dillonvale/Rayland). Turn left at the end of the off ramp onto Old St. Hwy 7. Turn right at the next stop sign onto St. Rt. 150 west (to Dillonvale). Stay on St. Rt. 150 at Dillonvale and go up a mile-long hill into Mt. Pleasant. At the stop sign at the top of the hill in Mt. Pleasant, turn left onto St. Rt. 647. Go about 3/8 mi. and the Presbyterian Church is on the left. **From the south:** From Bridgeport, OH, take US 250 west about 11 miles. Turn right onto St. Rt. 150 (east) and go about four miles to Mt. Pleasant. After the stop sign in the center of town, go straight about 3/8 mi. and the Presbyterian Church is on the left. For GPS or Mapquest, the address is 123 Union St., Mt. Pleasant, OH 43939. **Parking** is behind or along side the church
